Course Description

Principles of microelectronic device fabrication. Emphasis on the fundamentals of microfabrication processing and microelectronic device process flows. 3 Credits Grading Scheme: Letter Grade

Course Objectives

This course focuses on advanced modern IC processing. We will cover each of the processing steps in detail, including oxidation, dopant diffusion, ion implantation, lithography, thin film deposition, and etching. We will emphasize how these steps combine to build modern IC devices. We will also give examples of how software packages are used to simulate and model the physics and chemistry of IC fabrication.
