This course is co-listed with the graduate class. The homework portion of the graduate section will involve additional work with respect to the undergraduate section. The exams will also involve additional questions or takehome questions for the graduate section with respect to the undergraduate section. Grading for the homework and projects are different from the undergraduate course. The graduate and undergraduate sections will be graded separately, for which the graduate section has additional problems and different weights for all problems. EEL 5934 has computer software based simulation and design and is required to submit term projects and final reports. Each test has takehome questions, which can be completed using computer simulation using provided design tools.
