Course Description

Introduce the advanced topics of IoT security and privacy challenges. Systematically analyze IoT security from hardware, communication, and system perspectives.

Course Pre-Requisites / Co-Requisites

Prereq: Knowledge of microprocessor applications and proficiency in programming in C.

Course Objectives

This course should be a very gentle introduction to IoT security, mostly at the device level, through a series of hands-on labs. We will be providing a PCB with an ESP32 and a few simple peripherals which we use in said labs. We will be exploring issues related to the malicious access of physical ports (UART/JTAG), recovery and editing of firmware, and some network level security such as Man-in-the-Middle attacks using mitmproxy, as well as standard methods to mitigate these threats.
