### **Course Description**

Senior-level study of wireless and mobile networks. Investigates telecommunication architectures and protocols for wireless sensor networks and wireless embedded systems; Wi-Fi and wireless local area networks; mobile adhoc networks; next generation cellular systems and satellite networks. (3 credit hours)

## Course Pre-Requisites / Co-Requisites

EEL 3701C and junior or senior standing.

## **Course Objectives**

In this course, students will learn about the basic operation and design of a wireless system. The students will apply their knowledge of advanced mathematics, basic science, and computer engineering to understand and evaluate the performance issues of modern and advanced wireless networks.

# **Materials and Supply Fees**

The materials are for a Group Project and individual labs: Wireless Kit: Purchase a 3-Xbee development kit and sensors (<\$100 if shared among the group). More experienced groups (that have taken MicroP1 and/or MicroP2) may want to use CC3100s instead of Xbees. At least one person in your group should already have many of the following items from previous courses: Arduino (optional), USB Splitter, DAV board, Females leads, Dual male/female leads, Breadboard, and Wire kit.

## **In-Class Recording**
