#### **Course Description**

Surveys current research topics in electrical and computer engineering via group discussion of select IEEE Spectrum (technical magazine) articles (1 credit) and allows students to dive deeper into a topic of their choosing via a project (2 credits). The project may consist of a hardware/software design build or a literature review report.

## **Course Objectives**

It is expected that the students will become familiar with state-of-the art topics in the field of electrical and computer engineering. Weekly group discussions where the students will take turns leading the discussion will occur in class. In addition, for a second credit, students can explore an area of their own interest through a design build or literature review report. Students can choose to register for 1 or 2 credits. Effective communication skills through leading group discussions and presenting slides on article synopsis's will be acquired.

# Attendance Policy, Class Expectations, and Make-Up Policy

Up to three articles will be discussed in depth each week in class. Two to three students will be chosen each week to lead the discussion of the articles. The students will have to present a synopsis of the article via slides and guide the discussion of the topics presented. Details covering basic physics and engineering principles to societal implications will be discussed for each article topic. Students who are not leading an article discussion will comment on a discussion board before the article is discussed in class as homework. The discussion leaders will use this content to address questions and steer their presentation content and the group discussion. Students will be expected to attend class and also participate in the live discussion. Class attendance will be taken for a grade. Two free attendance drops will be given. Students taking this class for two credits will present their projects on the last two day of the semester.

#### **In-Class Recording**

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session.

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
